UAPs (UFOs), Grounded in Reality, or Not. That is the Question

Portions of the following article were drawn from a *60 Minutes* episode that ran earlier this year, titled: *UFOs regularly spotted in restricted U.S. airspace, Bill Whitaker reports on the regular sightings of unidentified aerial phenomena, or UAP.* I'd like to perform a more detailed dissection on the perspectives of UAP/UFO whistle blowers, particularly Luis Elizondo. I hope some will find portions informative. *UAP* means *Unidentified Aerial Phenomenon*.

We start with some background. Elizondo spent 20 years running military intelligence operations worldwide in Afghanistan, the Middle East, and Guantanamo. He had no interest in the subject of UFOs until when in 2008 he was asked to join a project at the Pentagon called the *Advanced Aerospace Threat Identification Program*, or "AATIP." The organization consisted of a loose-knit mix of scientists, electro-optical engineers, avionics and intelligence experts who often worked part time. Elizondo, combed through data that revealed UAP, some which were pushing 6-to-700 g-forces, flying at 13,000 miles an hour and evading radar. They showed no obvious signs of propulsion, no wings, no control surfaces, and yet they somehow managed to defy the natural effects of Earth's gravity. They were recorded flying through air and water. It was speculated that they probably move through outer space as well.

Alas, AATIP's findings were met with skepticism, resulting in the Pentagon eliminating their funding in 2012. Elizondo and a handful of others managed to keep the mission on life-support. But eventually, out of frustration, he quit the Pentagon and AATIP in 2017. But before leaving, Elizondo managed to get help from Chris Mellon, who served as deputy assistant secretary of defense for intelligence for Presidents Clinton and George W. Bush. Mellon, having access to top secret government programs, helped Elizondo elevate the matter by getting the attention of Secretary of Defense. That would most likely have been Jim Mattis. Mellon grew concerned that UAP reports were not being taken seriously. He decided to up the stakes in 2017 when, as a private citizen, he surreptitiously acquired the three Navy videos that Elizondo had declassified. Mellon leaked the videos to the *New York Times*. He also joined forces with now civilian, Elizondo, and together they started telling their story to anybody who would listen,

including newspapers, *The History Channel*, and members of Congress. Within the *60 Minutes* interview, Mellon stated:

“We knew and understood that you had to go to the public, get the public interested to get Congress interested, to then circle back to the Defense Department and get them to start taking a look at it.”

“It’s bizarre and unfortunate that someone like myself has to do something like [leaking evidence to the NY Times] that to get a national security issue like this on the agenda.”

...
“So it’s not [from] us, that’s one thing we know.”

As an old saying goes, the squeaker the hinge, the more oil it gets. Last year, the Pentagon resurrected the defunct AATIP, renaming it the *UAP task force*, or *UAPTF*. Service members are now encouraged to report strange encounters. ...and the senate wants answers.

So, how have skeptics addressed the UAP

matter? Organizations like the *Skeptical Inquirer* have weighed in. Card carrying members are likely to be comforted when *SI* issued a new article titled: “*Keep UFO Reporting Grounded in Reality, Advise Skeptics*.” After reading the article I came away with the impression that *SI* believes heavy-duty analytical filters, now, more than ever, need to be applied. They suggested filtering out anecdotal reports in order to focus explicitly on “reliable” data. *SI* included examples of anecdotal data, such as “*It flew away at speeds unimaginable*” or “*turned in a way impossible for any aircraft today*”. This would place many of the statements Eliszondo had expressed on *60M* into the *SI* recycle bin. My concern is that if such filters were rigorously upheld it would likely result in missed opportunities to collect valuable information. IMHO, a lot of anecdotal data is still worth researching in more detail, particularly if such accounts are frequently recorded from non-related incidents. If I could use an analogy: Sometimes, throwing out anecdotal information is the equivalent of ignoring the body language and manic speech patters displayed by Rep. Jim Jordan

who tried to convince FOX anchor, Bret Baier, that he doesn’t really know how many times he talked to Trump during the January 6 insurrection at the U.S. Capitol. Anecdotally, does it really matter how many times Jordan talked to Mr. T? *Frack, yes!*



For decades, UFO Researchers have labored to make sense out of a growing database of both hard, as well as anecdotal data. The UFO anecdotal database (a rabbit hole, I might add) is littered with controversy and conflict, including among the researchers and UFO witnesses themselves. Organizations like *SI* have often exploited the differing opinions and personal conflicts that result from anecdotal information. It can be an effective *divide and conquer* tactic.

But reading between the lines of controversy and conflict, many researchers eventually realized that it was important to continue collecting subjectively experienced accounts

As the American media prepares to communicate this news to an eager public, the country’s leading skeptics’ organization is offering some helpful tips for journalists and media institutions to make sure the information they deliver is grounded in reality.

“Covering claims of sightings of UFOs (also sometimes called UAPs, unidentified aerial phenomena) has always posed challenges,” writes the [Committee for Skeptical Inquiry \(CSI\)](#), a program of the Center for Inquiry and publisher of *Skeptical Inquirer* magazine. “These stories may excite readers—but do they reflect any evidence that the only explanation of the incidents is an extraterrestrial, highly advanced space or aerial device?”

Almost certainly not. “Usually the prosaic explanations get little coverage compared with the early hype,” writes CSI. “This dynamic distorts the public’s (and the media’s) perceptions. Soon the debunked claims are replaced by new claims, and the cycle starts anew.”

Some of the tips and reminders offered by CSI include:

- “Unidentified” does not equal “aliens”: Sources often conflate sightings of something in the sky with extraterrestrials. Most UFOs become IFOs (identified flying objects).
- Just because alien life is possible, it doesn’t mean they’re here: Many confuse the fact that astronomers believe, on a statistical basis, that life (even intelligent life) may exist elsewhere

Maintaining strict objective protocols on UAP encounters can be insufficient

When analyzing UAP testimony taken from witnesses, (See previous page: *Announcement from the Skeptical Inquirer*) one of the pointers the *Skeptical Inquirer* suggests reporters should guard against is accepting anecdotal testimony:

Anecdote is not data: Statements from sources such as, “It flew away at speeds unimaginable” or “turned in a way impossible for any aircraft today” are not reliable.

But how well does following such a filtered discipline work when FOX reporter, Bret Baier, asked Rep Jim Jordan whether he talked to Trump during the time of the January 6th insurrection. Jordan replied with:

I’ve talked to the former president umpteen times, thousands... I mean I many not thousands, but countless... countless times... I talked to the president... I never talk about what we talk about, so I don’t think that is appropriate, just like I don’t talk about what happens in republican conferences. So, I talked to the president numerous times... I continue to talk to the president [FOX reporter again interrupts and repeats that he is only interested in whether Jordan talked to the president during the Jan. 6 insurrection.] Yes... I mean I talked to the president... I’ve talked to the president so many... I

can’t remember all the days I talked to him, but I’m sure I talked to the president.

It’s true that Rep. Jordan eventually got around to answering the Baier’s question. Case closed! Or is it? When one analyzes Jordan’s rambling, fractionated reply (when a simple “yes” or “no” reply would have sufficed), speaking strictly anecdotally, I think many viewers would find themselves seriously asking the question of what is it that Jordan is trying to obfuscate, and why?



alongside the objectifiable hard data. This has been the conclusion of many well-respected investigators such as the late Allan Hynek (Scientific consultant to Project Bluebook) and Jacques Vallée (Read: *Forbidden Science* by Jacques Vallée.) To be clear, no one is arguing that hard data is less important than collecting anecdotal data. The trick is learning how to develop a sense of objectivity when it comes to analyzing subjective accounts. We should continue because ignoring anecdotal accounts doesn’t make them go away.

So, how do we go about addressing the UAP mystery?

While I’m all for a full disclosure, I can understand why the USG (US Government) and private thinktanks want to stall for time. I also agree that they that need to collect more information *and funding*. Since at present UAPs remain unknown, insofar as the intent of the report goes, the document came up with the following five classification categories:

1. Airborne clutter
2. Natural atmospheric phenomena
3. **USG or industry developmental programs**
4. **Foreign adversary systems**
5. **A catchall “other” bin.**

The contents lack detail. It also steered clear away from generating any informative conclusions. It did however manage to identify one UAP as a “deflating balloon.”


Can we handle contact and possible communication from whatever UAP turns out to be?

I think those of us lucky enough to have maintained a sense of curiosity in adulthood, (and who also received decent educations), would be able to handle future revelations of this sort. Up to this point I’ve been careful not to suggest an *extraterrestrial* category. I noticed the UAPTF report bent over backwards, scrupulously avoiding any suggested of an *extraterrestrial* category. Surprisingly, I sympathize, but only to a point.

While many of us are educated and remain curious about

the unknown, that still leaves hundreds of millions... possibly billions of earthlings vulnerable to falling through the psychological fault lines of having their personal paradigms unexpectedly fractured. It might be due to a crisis of religious dogma—perhaps a loss of faith, or perhaps having been forced to endure a lifetime of social conditioning which emphasized xenophobic

tendencies. Half the planet could easily end up fearing what the intentions of unknown intelligences might turn out to be. Many are likely to model their fears on the only psychological profile they have at their disposal: *Ourselves*. What do most nations possessed with superior power seem do unto other nations of lesser power? *Resistance is futile*.

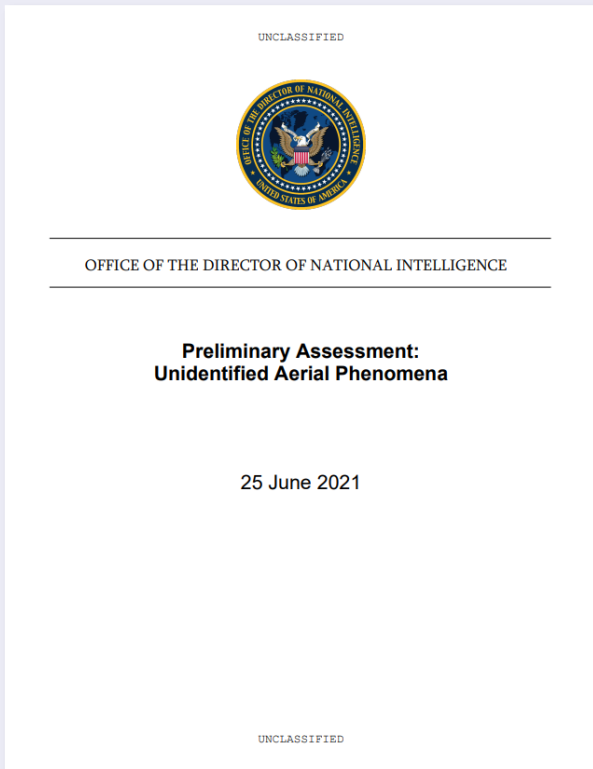

AVAILABLE REPORTING LARGELY INCONCLUSIVE

Limited data and inconsistency in reporting are key challenges to evaluating UAP. No standardized reporting mechanism existed until the Navy established one in March 2019. The Air Force subsequently adopted that mechanism in November 2020, but it remains limited to USG reporting. ***The UAPTF regularly heard anecdotally during its research about other observations that occurred but which were never captured in formal or informal reporting by those observers.***

After carefully considering this information, the UAPTF focused on reports that involved UAP largely witnessed firsthand by military aviators and that were collected

from systems we considered to be reliable. These reports describe incidents that occurred between 2004 and 2021, with the majority coming in the last two years as the new reporting mechanism became better known to the military aviation community. ***We were able to identify one reported UAP with high confidence. In that case, we identified the object as a large, deflating balloon. The others remain unexplained.***

UAP Collection Challenges:

Narratives from aviators in the operational community and analysts from the military and IC describe disparagement associated with observing UAP, reporting it, or attempting to discuss it with colleagues. Although the effects of these stigmas have lessened as senior members of the scientific, policy, military, and intelligence communities engage on the topic seriously in public, reputational risk may keep many observers silent, complicating scientific pursuit of the topic.

UAP PROBABLY LACK A SINGLE EXPLANATION

Other: Although most of the UAP described in our dataset probably remain unidentified due to limited data or challenges to collection processing or analysis, we may require additional scientific knowledge to successfully collect on, analyze and characterize some of them. We would group such objects in this category pending scientific advances that allowed us to better understand them. ***The UAPTF intends to focus additional analysis on the small number of cases where a UAP appeared to display unusual flight characteristics or signature management.***

Increase Investment in Research and Development

The UAPTF has indicated that additional funding for research and development could further the future study of the topics laid out in this report. Such investments should be guided by a UAP Collection Strategy, UAP R&D Technical Roadmap, and a UAP Program Plan.

Scott: Yeah, I'm sorry I missed the get-together as well. Being shoed off the Memorial Union terrace premises by a

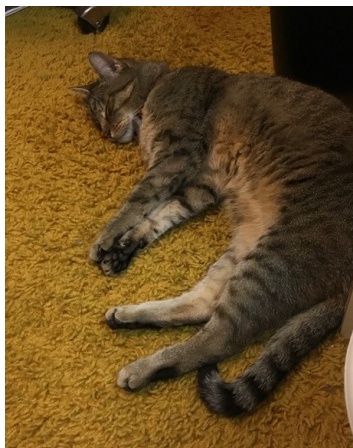
loud and obnoxious megaphone wouldn't be my favorite exit strategy either.
